NOTIFICATION

In exercise of the powers conferred by Section 4 read with Section 11 of the International Quality and Accreditation Board Charter Act, 2018, and the Global Assessor Accreditation & Continuous Professional Development Regulations framed thereunder, the International Quality and Accreditation Board (IQAB), on the recommendation of the Academic Council of the Global Assessor Academy, hereby notifies the convening of the **Global Assessor Academy Summer Symposium (2025–2026)** along with its following constituent modules, regional academic clusters, and participating specialized wings, namely:—

1. International Peer Review & Institutional Audit Training Division (Geneva Hub)
2. Higher Education Quality Assurance & Accreditation Unit (London Wing)
3. Healthcare & Clinical Accreditation Standards Cell (Singapore Hub)
4. Technical & Vocational Education Competency Assessment Forum (Dubai Centre)
5. Digital Learning, AI in Quality Auditing & Ed Tech Standards Directorate (San Francisco Wing)
6. Environmental, Social & Governance (ESG) Institutional Metrics Division (Tokyo Centre)
7. Global Assessor Ethics, Governance & Grievance Redressal Council (New Delhi Hub)
8. Research & Doctoral Program Assessment Committee (Sydney Chapter)
9. Post-Accreditation Continuous Monitoring & Quality Benchmarking Centre (Toronto Wing)
10. Lead Assessor Master class & Fellowship Convocation Cell (Global Secretariat)

as the officially recognised global symposium and training conclave for the purposes of the aforesaid Charter with immediate effect, subject to strict adherence to the following statutory conditions and academic regulations:—

- a. That all nominated assessors, peer reviewers, and candidate quality auditors representing constituent and affiliated institutions shall undergo mandatory enrolment and baseline competence verification on or before the prescribed cut-off date;
- b. That participating institutions and academy centres shall adhere strictly to the Guidelines, Ethical Codes, and Competency Framework issued by the IQAB Governing Council and the Global Assessor Academy from time to time;

- c. That appropriate provisions in the Memorandum of Understanding (MoU), Academic Statutes, and Assessor Bylaws of the Global Assessor Academy shall be formally enacted to:
- (i) Nominate a Principal Assessor Liaison Officer to coordinate directly with the IQAB Academic Directorate;
 - (ii) Establish a transparent Assessor Grievance Redressal and Appeal Tribunal for evaluation reviews;
 - (iii) Maintain a published International Register of Certified Lead Assessors (IRCLA) updated in real-time;
 - (iv) Enforce mandatory Continuous Professional Development (CPD) credit requirements for annual recertification;
- d. That the Phased Rollout Schedule and Key Milestones for the Global Assessor Academy Summer Symposium specified in the Schedule hereunder shall be binding and non-negotiable for all participating delegations:
